All Co-Borrowers on the loan must sign the request. You will be notified *only* if you do not qualify for the Skip-A-Payment offer. Excludes Home Equity and loans exceeding a 7 year term origination. Accounts must be in good credit standing.

### Dormant Accounts

Mokelumne Federal Credit Union would like to make you aware:

If your account has not experienced activity for at least 12 months, it is classified as dormant or inactive.

Dormant / inactive accounts are subject to a \$5.00 per month fee. You can easily reactivate your account and avoid this fee by making any kind of transaction to your account.

State law requires account balances be surrendered or escheated to the State of California if the owner has not generated account activity within three years.

To avoid this, we encourage you to take action as soon as possible. Please contact a branch nearest you to assist in protecting your funds.



Accounts with no activity for 12 months are classified as dormant and subject to fees
