Good-to-Know Debit Card Info

Limits— MFCU Debit Cards have different spending limits, depending on how you complete your transactions:

- PIN (cash) transactions- \$500 limit per day
- Point of Sale (credit) transactions- \$1000 limit per day
- Contactless (tap 'n pay) transactions- \$250 per transaction

Need to make a Point of Sale purchase that exceeds \$1000? No problem! Call and speak with an MFCU representative during regular business hours to request a limit increase. *Note: Cash and contactless limits cannot be increased.*

Remote Control Cards— Available on MFCU's Mobile App, you can FREEZE (temporarily disable) your debit card, day or night, for any reason! Freeze

your card when you can't find it or just want to help limit fraudulent purchases from clearing your account. You have the ability to turn your card off and on, at your discretion. It's safe, quick and convenient.

Dormant Debit Cards— Did you know you have to use your debit card at least one time every six months, or your card will be closed for inactivity? Avoid card closures and unnecessary re-order fees by using your card today!
